## FAI Community Learning Services

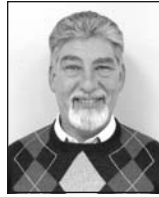
The Life Enrichment Center (LEC) recently received FAI Board approval to provide a new service called **Community Learning Services**. This service is offered through the Developmental Disabilities Administration (DDA) and falls under COMAR regulations for Day and Vocational programs. DDA approval is pending and is expected by spring. The service is for individuals who are interested in receiving a majority of their services in the community. Community Learning Services will be provided in integrated environments where people have opportunities to connect with and participate with other community members. Persons interested may include those who are retired, employed in the community less than four hours per day, or who would like to explore varying or alternate employment goals. This service is different from traditional Day and Vocational services in that a majority of the 30-hour service week will take place in integrated community activities, and focus on job development, self-improvement, and health/well-being. Staff ratios will be no more than one staff to four individuals, unless a one to one staffing ratio has been allotted. This service was approved on a trial basis for one group of four individuals over the next year. The service will be discussed in advance with the parents/caregivers of the persons selected. The LEC director will report to the board on the progress, with a plan to provide this service to additional groups in 2012.

## Steve Huff is Quarterly Winner of LEC Achievement Award

When the Training Center and the Work Development Program (WDP) were combined into one component—The Life Enrichment Center (LEC)—staff revised the “Quarterly Trainee Award Recipient” program, which had been part of the former WDP for many years, into the new “LEC Achievement Award.” Any individual who attends the LEC is eligible to be nominated for this award. Staff nominates individuals based on: attendance, personal performance, safety awareness, IP progress and/or social and work interaction.

The recognition program was initiated to acknowledge all levels of accomplishments by program participants, regardless of their abilities or work skill level. The award was intended to be an incentive and positive experience for every individual, based on their accomplishments, rather than a competition between each other.

Each month the Award Committee selects the Recipient of the Month from the nominations received. This recipient receives a Certificate of Recognition, their picture on the LEC Recognition Board, and lunch out with the staff member who nominated them. The three monthly recipients in each quarter are then eligible for the Quarterly Award. The quarterly recipient receives a zippered, hooded sweatshirt with the FAI logo and their embroidered name, a Certificate, and recognition

in the “FAI Info” Newsletter and on the LEC Recognition Board.

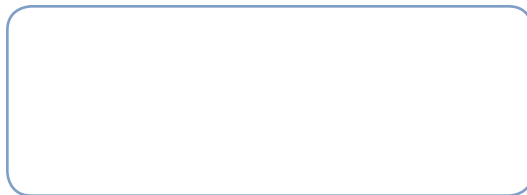
